General aim of the module: To understand how, in the 1980s and 1990s, the new world order imposed a new mode of management in which coordination was no longer carried out under the authority of the state but in transversal political networks and coalitions of different sectors of society, as well as the multiplication of social contestation against centralized power and local demands for citizen participation in public action and in the decision-making process.

Learning objectives:

The transition from government to governance: participatory democracy, a pillar of urban governance, the development of public-private partnerships (PPPs) in urban management, the role of the municipality in urban management and local development, the introduction of NICTs in urban management.
